GENERAL DIRECTIONS

ACCELERATE dramatically increases the rate of absorption of certain herbicides by reducing the surface tension of the spray droplet, and as uptake is more rapid, the rain-free period following application can be reduced.

MIXING

To reduce foaming add ACCELERATE when spray tank is nearly full.

COMPATIBILITY

ACCELERATE is compatible with Glyphosate 540 and Glyphosate G360, brushweed herbicides such as Eliminate Brushkiller, Eliminate, Eradicate 600, and other herbicides containing metsulfuron-methyl, picloram and/or triclopyr. Consult product labels for correct rate.
